






STREETS CONSTRUCTED ON EXPANSIVE SOILS SHALL BE DESIGNED IN ACCORDANCE WITH THE STATE OF CALIFORNIA DEPARTMENT OF TRANSPORTATION HIGHWAY DESIGN MANUAL.

SUBGRADE AND AGGREGATE BASE SHALL BE COMPACTED TO 95% RELATIVE DENSITY.

2. REFER TO STD ST-31 FOR PAVEMENT REPLACEMENT.
3. ROLLED CURB AND GUTTER IS TO BE USED IN LIEU OF VERTICAL CURB AND GUTTER IN ALL NEW SUBDIVISIONS, VARIANCE FROM THE ENGINEERING DEPARTMENT SHALL BE OBTAINED PRIOR TO ANY WORK.
4. SUBMIT STREET MAINTENANCE AGREEMENT FOR OWNERSHIP AND MAINTENANCE OF THE STREET TO THE CITY ATTORNEY AND SECURE HIS APPROVAL.
5. SIGNS, PAVEMENT MARKINGS, TURN LANES OR ADDITIONAL THROUGH LANES MAY BE REQUIRED BY THE CITY ENGINEER, PLANNING COMMISSION OR CITY COUNCIL.
